

## DANCE4LIFE presents SUMMER EXPLOSION 2016 Policies

### Payments

All payments may be made by cash, check, or thru the website at [www.dance4lifedelaware.com](http://www.dance4lifedelaware.com). Add \$3 to the total when paying online. This is the processing fee. Make checks payable to DANCE4LIFE. Full tuition must be paid before the first day of the program. Any returned checks will incur a \$35 penalty fee. At which point, all fees, (registration, full tuition, and penalty), must be paid in cash. Sibling discount available for up to (3) members from the same household. First member pays full price, second member receives 10% off total, and third member receives 20% off total. **The discount applies to tuition only, NOT the registration fee. ALL PAYMENTS ARE NON-REFUNDABLE.**

### DROP OFF & PICK UP

Students may begin arriving at 8am. Students **MUST** be picked up immediately after the close of the daily session at 4pm. Students who are not immediately picked up will have a \$1 per minute supervision fee added to their account. This fee must be satisfied in cash before the start of the following day. Fees not paid will result in the student not being permitted to participate in class. No exceptions. **\*Extended stay hours are available from 4pm-6pm daily, at a weekly rate of \$50 per student. NO FURTHER DISCOUNTS ARE APPLIED FOR EXTENDED STAY HOURS.**

### FOOD AND DRINK

Be sure to pack a lunch and snack daily for the students. Sandwich, salad, fruit and vegetables along with clear bottled water, are the only items permitted. Refrain from packing chips, cookies, candy, gum, cake, donuts, etc as these items create crumbs, messy clean up and invite unwanted critters into our dance home, (ants, roaches, mice etc).

### DRESS CODE

Students are required to be dressed in proper dance attire with shoes applicable for class. Leotards, tights, dance shorts, or sports bras are acceptable for the summer session. Hair must be pulled off of face and neck secured in a bun or ponytail. Ballies, beads and or barrettes are not permitted in class. Please adjust hair accordingly. A thin elastic headband in **BLACK ONLY**, may be worn in class to secure bangs. Leotards and tights should be free of holes and runs. Tights that have a separation line on the thighs, or footless fashion tights with a lace/rhinestone bottom are not permitted. **NO jewelry** is to be worn. Panties are not to be worn under dance clothes, as your dance attire is the only clothing needed for instruction. Unprepared students will not be permitted to participate in class.

### STUDIO ETIQUETTE

DANCE4LIFE is an environment that promotes a safe haven for learning, both physically and emotionally. All clients, **STUDENTS** and **PARENTS/GUARDIAN** alike, are commissioned to act in respectful and honorable fashion at all times. Clients that handle themselves in an irate, disrespectful, or offensive manner will be immediately dismissed from the program. **Students can and will be dismissed from the program based on the conduct of their parent/guardian.** Refunds will not be given.

### CLASS OBSERVATION

No one is permitted to observe classes. The highly anticipated end of summer concert will showcase the progress and all that the dancers have mastered in their daily training.
